Description of Material Information or Fact	<p>Kindly be informed that we have received an official copy of Supreme Court of Republic of Indonesia Verdict Number 2845 K/Pdt/2017 towards the cassation of the Appeal Verdict Number 138/PDT/2016/PT.DKI on civil lawsuit Number 740/Pdt.G/2014/PN.Jkt.Sel which was filed by Lani Wibowo ("Plaintiff I") and Elliana Wibowo ("Plaintiff II") (jointly referred to as the Appelle in Cassation/formerly the Appellants in high court level/formerly the Plaintiffs) against PT Big Bird ("BGB" or the "Defendant I"), Dr. H. Purnomo Prawiro Mangkusudjono in his capacity as the Director of BGB, Mrs. Endang Basuki and Mrs. Dolly Regar as the member of the Board of Commissioners of BGB which in this case were referred as the Appeal Petitioners in Cassation/formerly the Appelles in high court level/formerly the Defendants, along with other parties among others, PT Blue Bird (the "Company") as one of the Co-appelle in Cassation/formerly the Co-appelle in high court level/formerly Co-defendant), with decisions are as follows:</p> <ol style="list-style-type: none">1. To reject the Cassation petition from the Appeal Petitioners (1) BGB, (2) Dr. H. Purnomo Prawiro Mangkusudjono, (3) Mrs. Endang Basuki and (4) Mrs. Dolly Regar.2. To punish the Appeal Petitioners in Cassation Level to pay court costs in amount of Rp 500,000.- (five hundred thousand Indonesian Rupiah). <p>Previously, DKI Jakarta High Court with its Verdict number 138/PDT/2016/PT.DKI has decided on the appeal level, as follows:</p> <ol style="list-style-type: none">1. To accept claims from the Defendants partially2. To state that the Plaintiff I as the holder of 328 shares in BGB, and the Plaintiff II as the holder of 1,148 shares in BGB.3. To order Defendant I to register the names of Plaintiff I and Plaintiff II as the shareholders of BGB in the share register of BGB.
